

Well it is that time of year to start thinking about getting ready for the fall and winter. I hope every one had a great summer.

Just to let you know that this will be my last article in the newsletter as your maintenance man. I have been doing this for about 17 years and it is time to let someone else take over. It has been a pleasure to work here on maintenance and I feel that I have helped in making some improvements over the years and hopefully the new maintenance person will have new ideas and help improve things more. I want to thank everyone who has volunteered in the past and realize that a lot of the things couldn't of happened without them. Thank You All!

I want to thank Bill Hester for his help again this year on maintenance. Without him some of the things probably wouldn't have gotten done. I could always count on him and his help was much appreciated.

I want to thank Bill H. and Terry Billings with their help putting the main dock and the swim buoys in this year.

This spring we had four volunteer work days, and I want to thank those that helped. The turnout was less than we expected, but the ones who helped where: Theron Shinew, Kim Weiber, Dave Crumbaugh, Stacy and Terry Billings. (Theron and Kim were at all of them). BRUSH AND COMPOST PILES:

We have areas by the RLMC office to take your brush and compost when you do your fall cleanup. Just follow the signs and put the debris on the designated piles. New this year we have 2 burn spots at the brush pile area, Please put the brush where the signs designates. There is a sign at the brush pile stating what can be put on that pile. Please no big logs or stumps on the brush pile. Also do not put mulch or wood chips on that pile and please don't put any trash on either pile.

Dates to Remember:

November 1st We will start taking boards out of the spillway. Winter level should be reached by November 15th (depending on the weather)

INSIDE BOAT STORAGE:

We put the boats in inside storage on a first come, first serve basis. We don't reserve spots. We do fill the barns so get your boats in early. The prices on boat storage went up this year, so check the boat storage slip with the new prices. Also this season all the boats will be taken out the second Saturday in May (May 9th 2026) ALL BOATS WILL BE TAKEN OUT ON THIS DATE.

We will be putting boats away on Monday, Wednesday and Friday nights. After September 21st, we will be putting them away more frequently. You can drop your boat off behind the office (building #5) anytime. You can get a storage slip from the office, website, or from the cabinet on the fence by the gate to the outside storage area.

YOU NEED TO MAKE SURE YOU HAVE A TAG ON YOUR BOAT WITH YOUR NAME AND PHONE NUMBER ON IT. MAKE SURE YOU HAVE YOUR SLIP FILLED OUT AND PUT BACK IN THE CABINET. YOU CAN PUT YOUR CHECK MADE OUT TO RLMC IN THE DROP BOX BY THE OFFICE. IF YOU ARE NEW AND ARE UNSURE WHAT TO DO, CONTACT ONE OF THE BOAT STORAGE COMMITEE PEOPLE ON THE LIST.

All fees are due at time of storage. Payments in cash need to taken to the office when the office is open. Only property owners in good standing will be allowed to store items in storage. RLMC is not responsible for lost or damaged property stored on corporation property. Please obtain your own insurance.

OUTSIDE BOAT STORAGE:

All outside storage at the boat storage area is FREE. All items stored outside, must be tagged with your name, phone number, and a slip filled out with the description of item stored. Items stored must have a current registration or license plate. ALSO THESE ITEMS MUST BE TAKEN OUT OF THE STORAGE AREA AT LEAST ONCE A YEAR! Tags and slips are available at the main gate entrance or at the office. To get an item into the outside storage area you need to contact one of the members on the boat storage committee (see list above), or stop at the office during office hours.

PONTOON TRAILERS:

Also as a reminder, the lake has two pontoon trailers available for use free of charge. Please use the lights and keep your travel to a radius of 25 miles. PLEASE REMEMBER TO SIGN OUT THE TRAILER ON THE TRAILER LOG THAT IS IN THE CABINET ON THE FENCE. ALSO IF YOU NEED THE TRAILER OVER NIGHT, LET SOMEONE ON THE BOAT STORAGE COMMITTEE KNOW.
